Important announcement

With the publication of the January 2020 index, GBoS has updated the official CPI series. This involves updating the weights and product basket as well as a number of methodological improvements. These updates improve the transparency, relevance and representativity of the CPI. For the first time, GBoS will also be calculating CPI indexes for urban and rural areas. These estimates are available on our website. See www.gbosdata.org/downloads, www.gambia.opendataforafrica.org/nsdp or the Annex to this release for full details.

To highlight these improvements, the long run CPI index has been re-referenced (rescaled) to January 2020=100. Please note that historical inflation rates are unaffected by this rescaling.

From June 2019 to June 2020, the year on year All-items Consumer Price Index (CPI) inflation rate increased by 5.1 percent. Food and Non-Alcoholic Beverages increased by 5.6 percent whilst Non-Food Products rose by 4.2 percent.

In June 2020, the All-items CPI index was 101.61, an increase of 0.2 percent over the May 2020 All-items index of 101.42.

From June 2019 to June 2020, within Food and Non-Alcoholic Beverages, ‘Oils and Fats’ increased by 18.1 percent, ‘Fish’ increased by 15.1 percent, ‘Fruits and Nuts’ increased by 10.4 percent, ‘Bread and Cereals’ increased by 9.4 percent, and ‘Meat’ increased by 3.1 percent.

Over the same period, for the Non-Food products, major increases were recorded by ‘Miscellaneous’, 22.3 percent, ‘Furnishing, Household Equipment, etc.’, 5.8 percent, ‘Clothing and Footwear’, 5.3 percent, and ‘Hotels, Cafes and Restaurant’, 4.6 percent.

From May 2020 to June 2020, the highest inflation rates were for ‘Oils and Fats’, 3.1 percent, ‘Sugar, jam, honey & sweets’, 1.9 percent, ‘Meat’, 1.7 percent and ‘Bread and Cereal’, 0.7 percent.

Using the 12 months-moving-average measure, the annual inflation rate was 4.6 percent in June 2020 compared to 4.9 percent recorded in May 2020.

Figure 1: Annual changes – Comparison with the same month of the previous year (June 2019 – June 2020)

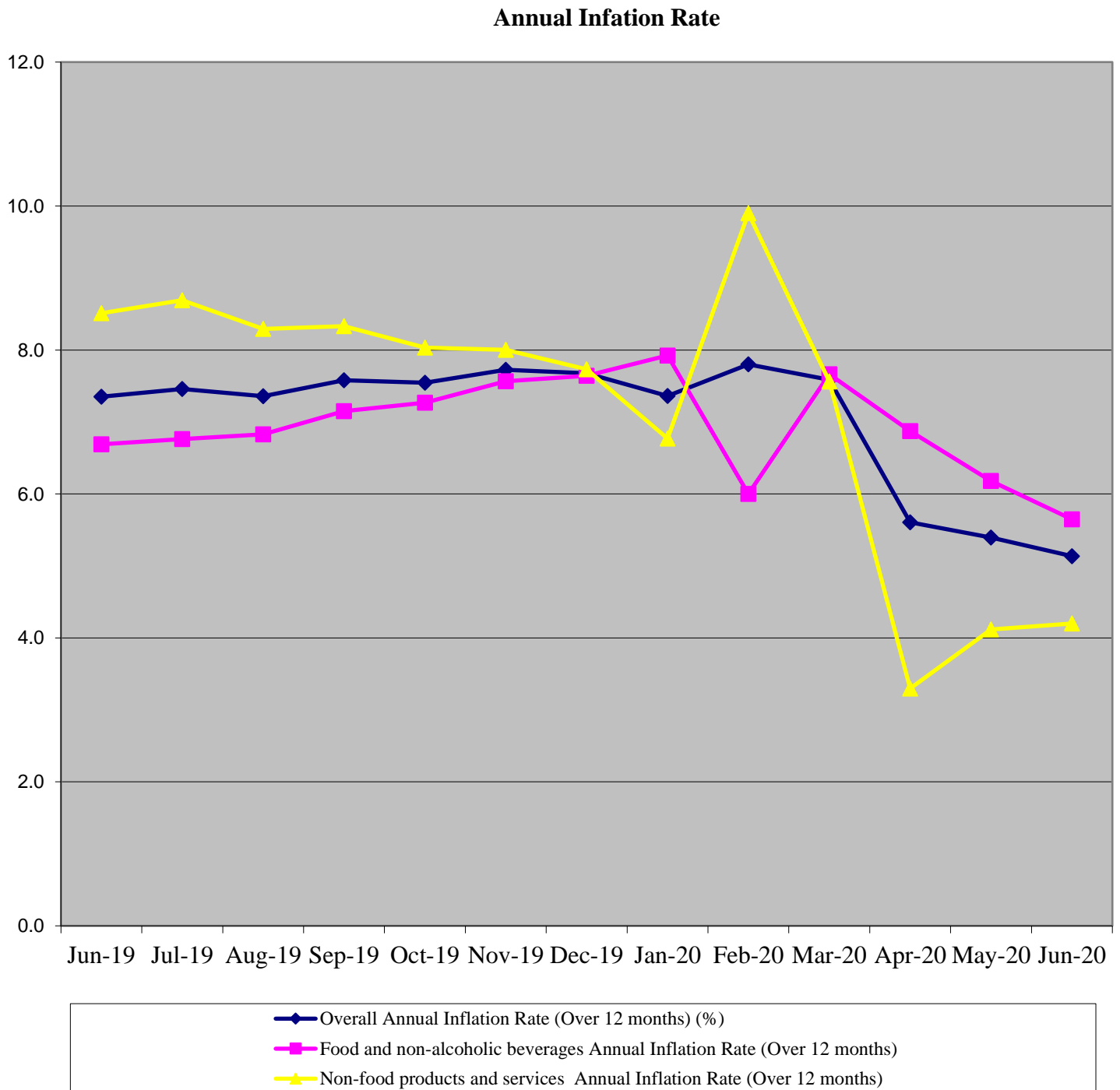
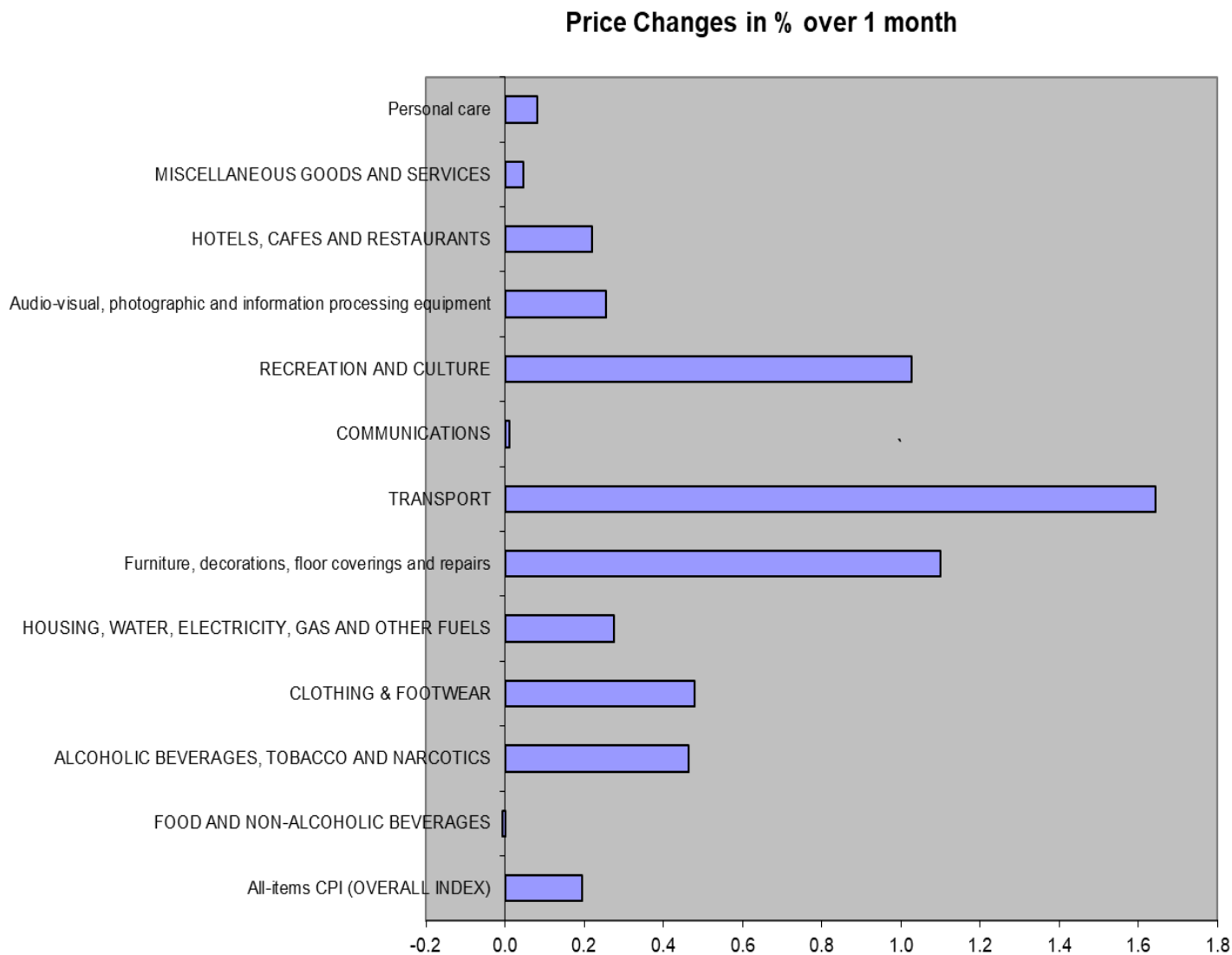


Figure 2: Monthly changes - Comparison with the previous month: May 2020 to June 2020
