II. Preface

This report presents International Merchandise Trade Statistics of The Gambia (IMTS) for the second quarter of 2024. It aims to show the outlook of trade between The Gambia and its trading partners during the period under review. It could also serve as a catalyst to enhance the investment drive of the country. The International Merchandise Trade Statistics unit under the Directorate of Economic Statistics of the Gambia Bureau of Statistics (GBoS), receives monthly raw trade data extracted from the Customs and Exercise Department of the Gambia Revenue Authority (GRA) database ASYCUDA World (Automated System for Customs Data) in American Standard Code for Information Interchange (ASCII) format for processing using EUROTRACE¹.

Data cleaning is continuous as various tables are produced to feed into the reports. The database is therefore updated from time to time to take account of adjustments made from the input source.

The report contains a wide range of trade statistics between The Gambia and its partners. This avails data users with information to facilitate planning and decision making. Data can be provided to users based on the level of breakdown requested up to six (6) or eight (8) digits according to the Harmonized System (HS).

The quarterly report contains data on the Trade Balance, Imports and Exports by major trading partners. The latest quarterly reports can be accessed on the GBoS website (www.gbosdata.org). For users who have specific data needs, the International Merchandise Trade Statistics Unit could offer the necessary assistance.

The GBoS wishes to express its profound gratitude to the ASYCUDA World Unit of GRA, for making available the necessary data for the compilation of the IMTS. We hope that users will find this report useful.

IV. Concepts and Definitions

Monthly trade summary: Includes imports, exports and re-exports and total exports disaggregated by month.

Trade flow by selected continents and economic zones: Is the value of trade between The Gambia and selected geographic and economic zones.

Direction of trade: Trade flows from and to main trading partners. The ranking is done based on highest ten by value in Gambian Dalasi (GMD) and country.

Trade flow by top ten products: This indicates trade flows (import, exports, re-exports) by main products sorted based on the highest Cost Insurance and Freight (CIF) or Free on Board (FOB) value in (GMD'000') at 2-digit Harmonized System product code which groups related commodities.

Export trade: The exports of merchandise goods are valued at FOB and it refers to all movable goods going out of the economic territory. Share of domestic exports to total trade is the value of all goods exported to the rest of the world divided by total trade multiply by 100.

Import trade: The value of imported goods includes the CIF value; it refers to all movable goods coming into the economic territory. Share of imports to total trade is the value of all goods imported from the rest of the world divided by total trade multiply by 100.

Total Exports: This is the value of domestic exports plus re-exports.

V. Executive Summary

- The total value of imports in the second quarter of 2023 compared to the second quarter of 2024 increased from GMD13.8 to GMD16.2 billion.
- A total value of Imports GMD16.2 billion was incurred during the second quarter of 2024 compared to the same period in 2023 of GMD13.8 billion. This shows an increase of GMD2.4 billion over the period.
- The second quarters of both 2023 and 2024 shows larger importation of Mineral fuels.
- Salt and Oils/oleaginous fruits, Edible fruits and nuts, and Fish and Crustaceans were mostly exported in the second quarter of 2024.
- Senegal, China, and Belgium were the main import partners during the second quarter of 2024.
- Total Cement is the highest imported product amongst the selected product with GMD1.3 billion, followed by Sugar GMD1.0 billion, then Rice GMD659.4 million.
- Senegal and Cote d'Ivoire are the top two import partners from the ECOWAS regional bloc with GMD2.5 billion and GMD560.9 million respectively.

Summary of Quarterly Trade Statistics Second Quarter 2023-2024 VI.

Table 1 below shows the quarterly trade statistics. The total value of imports in the second quarter of 2024 compared to the first quarter increased from GMD15.8 to GMD16.2 billion. This indicates a rise in imports equivalent to GMD0.4 billion. However, the second quarter of 2023 compared to the second quarter of 2024, imports increased by GMD2.4 billion i.e. from GMD13.8 to GMD16.2 billion.

The value of total exports (i.e. domestic exports + re-exports) in the first quarter of 2024 decreased from GMD 1.2 billion to GMD638.8 million in the second quarter of 2024. Whereas the value of total exports in the second quarter of 2023 compared to the second quarter of 2024 decreased from GMD3.5 billion to GMD638.8 million.

Furthermore, the trend observed in the trade balance² between the second and first quarters of 2024 is taking a decline. This shows a decrease in the trade balance in the first quarter of 2024 from GMD14.6 to GMD15.6 billion in the second quarter 2024. However, the trade balance between the second quarters of 2023 and 2024 also decreased from GMD10.3 to GMD15.6 billion.

Imports by products VII.

Figure 2 shows the top three products imported in the second quarters of 2023 and 2024 respectively. Although the top three products imported are the same for both quarters, there are still some variations in the volume imported for each quarter. Mineral fuels were the highest imported product, 21.4 per cent of this product was imported in 2024 compared to 26.3 per cent for the same period in 2023. This was followed by importation of

Cereals which accounted for 11.2 per cent and 14.8 per cent in the second quarters of 2023 and 2024 respectively. The third most imported product was Vehicles which shows that less of the product was imported during the second quarter of 2024 with 8.7 per cent compared to the second quarter of 2023 with 10.1 per cent.

VIII. Exports by product

Exports of top three products from figure 3 shows that Edible Fruits and Nuts, fish and crustaceans, and Salt and Oil Seeds were mostly exported in the Second quarters of 2023 and 2024. Furthermore, Oil seeds and oleaginous fruits (55.5%) was the highest exports in the second quarter of 2024 while Edible Fruits and Nuts was the highest export for the same period in 2023.

IX. Imports of selected products for Second quarter 2024

Imports of selected products for the second quarter of 2024 shows that the highest imported product was Total Cement GMD1.3 billion, Sugar GMD1.0 billion, Rice GMD 659.4 million. The Lowest among the selected products is Alcohol GMD4.1 million.




Figure 4: Imports of Selected Products for Second Quarter 2024 GMD '000'

Edible fruits and Nuts

Figure 5 below shows imports from partners for the second quarters of 2023 and 2024. The top three countries where most of the goods were imported from during the second quarter of 2023: Senegal GMD2.1 billion, India

GMD2.0 billion and China GMD1.3 billion. Whereas, during the second quarter 2024, most of the imports were from Senegal GMD2.5 billion, China GMD1.8 billion, and Belgium GMD1.4 billion.

Table 3 below shows that India had the largest share of domestic exports from The Gambia in 2023 with (24.4%) While China has the largest share in the second quarter of 2024 with (64.4%), whereas United Kingdom and India (23.9%) and (15.9%) had the second highest share of export from The Gambia in the second quarters of 2023 and 2024 respectively. The third largest partners of exports from The Gambia were China (18.3%) and The United Kingdom (10.2%) in the second quarters of 2023 and 2024 respectively.


