IV. Preface

This report presents The Gambia's International Merchandise Trade Statistics (IMTS) for the Fourth Quarter of 2024. It aims to show the trade outlook between The Gambia and its trading partners during the period under review. It could also catalyze to enhance the investment drive of the country. The International Merchandise Trade Statistics Unit, under the Directorate of Economic Statistics of the Gambia Bureau of Statistics (GBoS), receives monthly raw trade data extracted from the Customs and Exercise Department of the Gambia Revenue Authority (GRA) database ASYCUDA (Automated System for Customs Data) World in American Standard Code for Information Interchange (ASCII) format for processing using EUROTRACE¹.

Data cleaning is continuous, as various tables are produced to feed into the report. The EUROTRACE database is therefore updated from time to time to take account of adjustments made from the input source.

The report contains a wide range of trade statistics between The Gambia and its trading partners. This provides data users with information to facilitate planning and decision-making. Data can be provided to users based on the level of breakdown requested from two (2), four (4), six (6) to eight (8) digits according to the Harmonized System (HS).

The quarterly report contains data on the Trade Balance, Imports, and Exports by major trading partners. All Trade Statistics reports can be accessed on the GBoS website (www.gbosdata.org). For users who have specific data needs, the International Merchandise Trade Statistics Unit could offer the necessary assistance.

GBoS wishes to express its profound gratitude to the ASYCUDA World Unit of GRA for making available the necessary data for the compilation of the IMTS. We hope that users will find this report useful.

VI. Concepts and Definitions

Monthly trade summary: Includes imports, total exports, and trade balance disaggregated quarterly.

Trade flow by continents and regional economic blocs: This is the value of trade between The Gambia and all continents and regional economic blocs.

Direction of trade: Trade flows from and to main trading partners. The ranking is done based on the highest ten by value in Gambian Dalasi (GMD).

Trade flow by top ten products: This indicates trade flows (import, exports, re-exports) by main products sorted based on the highest Cost, Insurance and Freight (CIF) or Free on Board (FOB) value in (GMD'000) at 2-digit Harmonized System (HS) product code which groups related commodities.

Export trade: It refers to all movable goods going out of the economic territory. The exports of merchandise goods are valued at FOB. The share of domestic exports to total trade is the value of all goods exported to the rest of the world divided by total trade multiplied by 100.

Import trade: It refers to all movable goods coming into the economic territory. The imported goods are valued at CIF. The share of imports to total trade is the value of all goods imported from the rest of the world divided by total trade multiplied by 100.

Re-Exports: It refers to the export of goods previously recorded as imports.

Total exports: This is the value of domestic exports plus re-exports.

Trade Balance: It refers to the difference between total exports and imports. It could be a surplus or deficit depending on trade performance.

VII. Executive Summary

- The total value of imports recorded in the fourth quarter of 2024 is GMD15.3 billion, compared to the fourth quarter of 2023 shows an increase from GMD 13.0 billion to GMD 15.3 billion, representing an increase of GMD 2.3 billion over the period.
- The fourth quarter of both 2023 and 2024 shows that Mineral fuels have the largest value of imports.
- Oil seeds and Oleaginous fruits, Salt, and Fish and crustaceans were mostly exported in the fourth quarter of 2024.
- Belgium and Senegal, were the main import partners during the fourth quarter of 2024.
- In the fourth quarter of 2024, Rice has the highest imported value among the selected products with GMD 1.2 billion, followed by Cement GMD 1.1 billion, then Sugar GMD 642.3 million.
- Nigeria and Senegal were the top two import partners from the ECOWAS regional bloc with GMD 2.5 billion and GMD 2.0 million respectively in the fourth quarter of 2024.

Summary of Quarterly Trade Statistics 4th Quarter of 2023-2024

Table 1 shows the quarterly trade statistics. The total value of imports in the fourth quarter of 2024 compared to the third quarter decreased from GMD 20.6 billion to GMD 15.3 billion. This indicates a decrease in imports equivalent to GMD 5.3 billion. Furthermore, in the Fourth quarter of 2023 compared to the Fourth quarter of 2024, imports increased by GMD 2.3 billion, i.e., from GMD 13.0 to GMD 15.3 billion.

The value of total exports (i.e., domestic exports and re-exports) in the fourth quarter of 2023 compared to the fourth quarter of 2024 increased from GMD 541.2 million to GMD 827.6 million.

Additionally, the trade balance between the third and fourth quarter of 2024 shows an increase from GMD19.9 billion to GMD14.5 billion. On the contrary, the trade balance between the fourth quarter of 2023 and 2024 shows a decreased from GMD12.4 to GMD 14.5 billion.

Imports by Products IX.




Figure 2: Imports of Top Three Products for the Fourth Quarter of 2023 and the Fourth Quarter of 2024 (in percentages)

Figure 2 shows the top three products imported in the Fourth quarter of 2023 and 2024 respectively. Although the top three products imported are similar for both quarters, there are still some variations in the volume imported for each quarter. Mineral fuels were the highest imported product, 46.4 percent of this product was imported in 2023 compared to 40.4 per cent for the same period in 2024. This was

followed by the importation of Cereals which accounted for 6.1 percent in the fourth quarter of 2023 to 12.4per cent in 2024. The third most imported products were vehicles 4.8 percent in 2023 and salt 4.6 per cent.

X. Exports by Product




Figure 3: Exports of Top Three Products for the Fourth Quarter 2023 and the Fourth Quarter of 2024 (in percentages)

Figure 3 shows the exports of the top three products in the fourth quarters of 2023 and 2024. Oil seeds and oleaginous fruits have the highest proportion of imports 47.5 per cent in 2023 while Salt 33.6 per cent was the highest export in 2024. Salt shows an increase in proportion from 12.6 per cent in th quarter of

2023 to 33.6 per cent in the 4th quarter of 2024. Fish and crustaceans were also among the most exported products in the fourth quarters of 2023 and 2024 with 11.5 and 27.1 per cents, respectively.

XI. Imports of Selected Products for the Fourth Quarter of 2024




Figure 4: Imports of Selected Products for the Fourth Quarter of 2024 (GMD'000')

Figure 4 shows that the highest imported product was Rice GMD 1.2 billion, followed by cement GMD 1.1 billion, and Sugar GMD 642.3 million. The Lowest among the selected products is Tomato paste GMD 8.0 million.

XII. Trade by Partners

The Gambia's main import trade partners

Table 3 below shows imports from partners for the Fourth quarters of 2023 and 2024. The top three countries where most of the goods were imported from during the Fourth quarter of 2023 are Belgium, GMD 3.3 billion, Senegal, GMD 1.4 billion, and India, GMD 1.1 billion. In 2024, the highest import partner was Nigeria with GMD 2.5 billion, Senegal with GMD 2.0, and China with GMD 1.4 billion. The least import partner in the top ten was the United Arab Emirates (UAE) in the Fourth quarters of 2023 and 2024 with GMD 275.5 million and GMD 414.0 million, respectively.

XIII. The Gambia's main export trade partners

Table 4 shows that China had the largest share of exports from The Gambia; her share of exports decreased from 61.1 percent to 38.3 percent in the fourth quarters of 2023 and 2024, respectively. This is followed by India with 12.4 and 15.8 percent for the fourth quarters of 2023 and 2024 respectively.



XIV. Intra-Regional Trade Economic Community of West African States (ECOWAS)

Figure 6 shows the imports from the ECOWAS partners in the fourth quarter of 2024. Nigeria had the highest import value, GMD 2.5 billion, followed by Senegal, GMD 2.0 billion and Togo, GMD 324.2 million. Benin with the lowest import partner from the ECOWAS bloc with GMD 338 thousand.
