#### II. Preface

This report presents International Merchandise Trade Statistics of The Gambia (IMTS) for the year 2025. It aims to show the outlook of trade between The Gambia and its trading partners for the period under review. It could also catalyze to enhance the investment drive of the country. The International Merchandise Trade Statistics unit under the Directorate of Economic Statistics of the Gambia Bureau of Statistics (GBoS), receives monthly raw trade data extracted from the Customs and Exercise Department of the Gambia Revenue Authority (GRA) database ASYCUDA World (Automated System for Customs Data) in American Standard Code for Information Interchange (ASCII) format for processing using EUROTRACE<sup>1</sup>.

Data cleaning is a continuous process as various tables are produced to feed into the reports. The database is therefore updated from time to time to take account of the adjustments made from the input source.

The report contains a wide range of international trade statistics between The Gambia and its trading partners. This provides data users with information to facilitate planning and decision-making. Trade data can be provided to users based on the level of breakdown requested from two (2), four (4), six (6) to eight (8) digits according to the Harmonized System (HS).

The annual report contains data on the Trade Balance, Imports, and Exports by major trading partners. The latest reports can be accessed on the GBoS website (<a href="www.gbosdata.org">www.gbosdata.org</a>). For users who have specific data needs, the International Merchandise Trade Statistics Unit could offer the necessary assistance.

The GBoS wishes to express its profound gratitude to the ASYCUDA World Unit of GRA, for making available the necessary data for the compilation of the IMTS. We hope that users will find this report useful.

#### IV. Concepts and Definitions

**Trade summary:** Includes imports, total exports, and trade balance aggregated annually.

**Trade flow by selected continents and economic zones:** Is the value of trade between The Gambia and selected geographic and economic zones.

**Direction of trade:** Trade flows from and to main trading partners. The ranking is done based on the highest ten by value in Gambian Dalasi (GMD) and country/partner.

**Trade flow by top ten products:** This indicates trade flows (imports, exports, re-exports) by main products sorted based on the highest Cost Insurance and Freight (CIF) or Free on Board (FOB) value in (GMD'000') at 2-digit Harmonized System product code which groups related commodities.

**Export trade:** The exports of merchandise goods are valued at FOB; it refers to all movable goods going out of the economic territory. The share of domestic exports to total trade is the value of all goods exported to the rest of the world divided by total trade multiplied by 100.

**Import trade:** The value of imported goods includes the CIF value; it refers to all movable goods coming into the economic territory. The share of imports to total trade is the value of all goods imported from the rest of the world divided by total trade multiplied by 100.

**Total Exports:** This is the value of domestic exports plus re-exports.

#### V. Executive Summary

- The trade deficit widened sharply from GMD 46.2 billion in 2023 to GMD 64.6 billion 2024, driven by surging imports and declining exports.
- A total value of imports of GMD 68.0 billion was recorded in 2024; on the other hand, 2023 recorded an imports value of GMD 51.3 billion. This shows an increase of GMD 16.7 billion over the period.
- The total exports from the Gambia decreased from GMD 5.2 billion in 2023 to GMD 3.4 billion in 2024. This shows a decline of GMD 1.8 billion in the Value of total exports from The Gambia.
- Both 2023 and 2024 show a larger importation of Mineral fuels with 30.9 and 32.0 per cent of Imports, respectively.
- Edible fruits and nuts, Fish and Crustaceans, and Salt and Oils/oleaginous fruits were mostly exported in 2023 and 2024.
- Senegal, Belgium, and China were the main import partners in 2024.
- Rice is the highest imported product amongst the selected products with GMD 4.8 billion, followed by Cement GMD 3.4 billion, then Sugar GMD 2.5 billion.
- Senegal, Nigeria, and Côte d'Ivoire are the top three import partners from the ECOWAS regional bloc with GMD 14.4 billion, GMD 2.6 billion, and GMD 2.2 billion, respectively.

#### Summary of Annual Trade Statistics 2023-2024 VI.

Table 1 below shows the annual trade statistics. The total value of imports in 2024 compared to 2023 increased from GMD 51.3 to GMD 68.0 billion. This indicates a rise in imports equivalent to GMD 16.7 billion.

The value of total exports (i.e., domestic exports + re-exports) in 2023 decreased from GMD 5.2 billion to GMD 3.4 billion in 2024, which shows a decrease of GMD 1.8 billion.

Furthermore, the trade balance<sup>2</sup> was GMD 46.2 billion in 2023 compared to GMD 64.6 billion in 2024, illustrating a soaring trade deficit in a year. This shows that The Gambia is increasingly depending on Imports from 2023 to 2024.

#### VII. Imports by products




Figure 2: Annual Imports of Top Three Products for 2023-2024 in percentages

Figure 2 shows the top three products imported in 2023 and 2024, respectively. Although the top three products imported are the same for both years, there are still some variations in the proportions imported for each year. Mineral fuels were the highest imported product, 32.0 per cent of this product was imported in 2024, compared to 30.9 per cent in 2023. This was followed by the importation of Vehicles which accounted for 10.7 per cent in 2024 and 7.2 per cent in 2023. Cereals were the least imported in the top three with 10.1 per cent in 2024 and 8.6 per cent in 2023.

#### VIII. Exports by product




Figure 3: Annual Exports of Top Three Products for 2023-2024 in percentages

Figure 3 shows the Exports of the top three products for 2023 and 2024. Oil Seeds and Oleaginous Fruits became the primary export driver, indicating a massive shift in production or demand (possibly for groundnuts, sesame, or other oil crops) in 2024 with 72.6 per cent of The Gambia's exports from 19.8 per cent the in 2023, this was followed by Edible Fruits and Nuts with 8.6 per cent in 2024 then the least exported product in the top three is Fish and crustaceans with 5.0 per cent of Exports in 2024.

#### IX. Imports of selected products for 2024




Figure 4: Imports of Selected Products for The Year 2024 in GMD'000'

Figure 4 shows Imports of selected products for 2024, the highest imported product was Rice GMD 4.8 billion, Cement GMD 3.3 billion, Sugar GMD 2.5 billion, and Vegetable Oil GMD 1.6 billion. The Lowest among the selected products is Vinegar GMD 2.6 million.

# X. Trade by partners

#### The Gambia's main import trade partners

Table 3 below shows imports from partners for 2023 and 2024. The top three countries where most of the goods were imported from for 2023 were Senegal GMD 8.5 billion, India GMD 5.3 billion and China GMD 5.2 billion. In 2024, imports from Senegal nearly doubled compared to the previous year with GMD 14.4 billion recorded, this was followed by Belgium with GMD 6.8 billion and then China with GMD 5.9 billion. The least import partners in the top ten were the United Kingdom with 1.4 billion in 2023 and the United States with GMD 2.4 billion in 2024.

#### The Gambia's main export trade partners

Table 4 below compares The Gambia's domestic export distribution across top partners in 2023 and 2024. China and India showed the largest share of domestic exports in both 2023 and 2024, China had a share of (41.6%) in 2023. In 2024, China's share surged to (78.7%), consolidating its position as The Gambia's primary exports destination. India on the other hand dropped sharply from (16.9%) in 2023 to (7.6%) in 2024. The United Kingdom was the third-highest export partner in 2023 and 2024 with (8.5%) and (3.1%) of exports, respectively. Belgium and the Netherlands had the lowest share of domestic exports from the top ten with (1.0%) for Belgium in 2023 and (0.6%) for the Netherlands in 2024.

# XI. Intra-Regional Trade Economic Community of West African States (ECOWAS)

Figure 5 highlights data on imports from the ECOWAS partners in 2024. Senegal is by far The Gambia's largest import partner within the regional bloc, contributing GMD 14.4 billion-significantly higher than all other countries combined, this is followed by Nigeria with GMD 2.6 billion, Cote d'Ivoire with GMD 2.2 billion, and the country with the least imports to The Gambia from the ECOWAS states was Benin with GMD 1.2 million. The Gambia's intra-ECOWAS trade in 2024 is heavily concentrated with Senegal, Nigeria, and Côte d'Ivoire, reflecting strong regional ties with these economies. The other member states have negligible import volumes, suggesting limited trade integration with The Gambia.
